DETROIT— The Great Lakes Water Authority (GLWA) has hired Randal Brown to serve as the Authority's General Counsel. William Wolfson who served in that role since the establishment of the Authority, will transition to serving solely as the organization's Chief Administrative and Compliance Officer (CACO).
